NorthEast warrants that its insulating glass units will be free from material obstruction of vision as a result of dust or film formation on the internal glass surface caused by failure of the hermetic seal due to faulty manufacturing of the unit for THE LIFETIME OF YOUR HOME. (Condensation on external glass surfaces does not indicate a faulty product.) Stress cracks are warranted for six months. Deadlites are not warranted at all of seal failure or stress cracks.

This warranty does not apply to any of the following: Damage incurred during or after installation, including but not limited to ripped, cut, torn or bent screen wire; or breakage, cracks or scratches in glass, faulty or improper installation, building construction, design or handling, or abuse, misuse, accidents, flood, fire or acts of God.

**• VINYL EXTRUSION WARRANTY •**

The vinyl extrusion is warranted not to chip, peel, blister, rot or corrode. The vinyl is not warranted against fading or color change due to weather conditions, as weathering will cause any surface to gradually change. There isn't any implied or stated warranty for the use of brown color extrusions.
