THIS IS TO CERTIFY THAT THE RIGID VINYL WINDOWS & DOORS INSTALLED ON THE PREMISES OF

Northeast Windows USA warrants as follows:

1. Its windows and doors are free from material defects in manufacture and will not peel, corrode, rot, blister, or flake to the extent the extruder warrants against such issues; colored PVC will indeed fade overtime due to weather conditions as weathering will cause any surface to gradually change over time. There isn't any implied or stated warranty for the use of any color extrusions.
2. Its insulated glass units will be free from material obstruction of vision as a result of dust or film formation on internal glass surfaces by failure of the hermetic seal due to faulty manufacturing. Glass industry accepted imperfections are not covered under this warranty. (Per American Society for Testing and Materials guidelines) **10 Foot Rule Applies.**
3. Its hardware items (locks, keepers handles, hinges, rollers, latches and the like, will be free from manufacturing defects.

The limited warranty period for the vinyl shall be for the lifetime of the original purchaser.

The limited warranty period for Laminated exteriors shall be for twenty (20) years from the original date of manufacturing. Claims will be subject to Renolit Exofol FX's Warranty.

The limited warranty period for insulated glass shall be for twenty (20) years from the original date of manufacturing. **10 year prorata applies.**

The limited warranty period for screens and blinds between the glass shall be for one (1) year from the date of manufacture.

The limited warranty period for hardware items shall be for ten (10) years from the date of manufacture. Physical damage & misuse of items not covered.

Northeast Windows USA will provide free repair or replacement parts at its option, of any part that is proven defective due to manufacturing after inspection by Northeast Windows USA.

In order to obtain performance of this limited warranty, contact your supplier where you purchased the product or ship the product pre-paid along with proof of purchase, to: Northeast Windows USA, 1 Kees Place Merrick, NY 11566. The repaired or replaced product will be returned to you at your expense. Northeast Windows USA will bear no other expenses such as labor costs of any kind, freight, removal or reinstallation. This is the exclusive remedy available for any and all warranty and other claims. Service calls for any reason after the first year to your home will be charged at the prevailing rate.

This limited warranty does not apply to any of the following:

1. Damage incurred during or after installation, including but not limited to ripped, cut, torn or bent screen wire; animals or people walking through the screen; or breakage, cracks or scratches in the glass or in the vinyl.
2. Normal wear and tear.
3. Faulty or improper installation, building construction, design or handling.
4. Abuse, misuse, accidents, flood, fire or acts of nature.

Some states do not allow the exclusion or limitation of incidental or consequential damages or limitations on how long an implied warranty lasts, so the above exclusions and limitations may not apply to you. This limited warranty gives you specific legal rights, and you may also have other rights, which vary from state to state.
